Undergraduates must **complete a minimum of 12 semester hours for the spring and fall semesters** each year to maintain F-1 visa status; for graduate students, the minimum load at CU is 9 hours per semester. You must have prior authorization to take a course load that is less than these amounts. **Completed courses** are those in which you earned a grade of A, B, C, D, F or S. Grades of W, U and I do not count toward the total full-time load required by federal regulations.

**IMPORTANT NOTE:** If you receive money, you are “employed” even if your “employment” is an internship, co-op job, or goes by any other name. U.S. Departments of Homeland Security, Justice, and Labor regulations strictly limit where, when, and for how many hours you may be employed in the U.S. You are not allowed to be self-employed or to conduct a business via the Internet while in the U.S. Make an appointment with the International Office before you accept any job on campus or off campus so that the required authorizations can be obtained and the required SEVIS notifications can be made. You must maintain full-time status whether or not you are working on or off campus. Work is limited to 20 hours per week or less while school is in session. *You may work more than 20 hours per week during summer and official school breaks.* If you work illegally, you cannot be reinstated to F-1 visa status.
