

With on-going health concerns centered-on COVID-19, all residential students must follow University and Student Housing and Residence Life expectations as described in this agreement. Additionally, residential students agree to follow all University policies and procedures not limited to the Cameron University Code of Student Conduct, Student Housing and Residence Life Handbook, and Student Housing and Residence Life Contract.

Effective July 01, 2021, Cameron University has the following expectations for the entire campus community as we focus on limiting the spread of COVID-19. These are our communally held behavioral expectations:

- **Expectation 1:** Practice good hygiene. Wash your hands regularly and avoid touching your face.
- **Expectation 2:** Monitor your personal health daily.
- **Expectation 3:** If you are sick, stay home.
- **Expectation 4:** Respect personal space. The pandemic has affected each of us differently so please consider your proximity to others.
- **Expectation 5:** Cover your nose and mouth when you sneeze or cough. If you are more comfortable wearing a mask, then you are welcome to do so.

I understand that we are actively experiencing a local and national health crisis (COVID-19 pandemic). I value this community and agree to help protect myself and the rest of the Cameron University campus community by adhering to all additional related policies, including, but not limited to those listed in this agreement. I understand that it is my responsibility to frequently check my Cameron University student email along with <https://www.cameron.edu/covid-19> for any additional policies that might be instituted for the health and safety of myself and the Cameron University community.

I understand that as the COVID-19 situation evolves, Cameron University and the Office of Student Housing and Residence Life may need to make changes, including updating policies and procedures and/or creating additional policies and procedures as circumstances warrant to maintain resident/community safety.

I agree to follow all policies and expectations and will respect the personal space of others including but not limited to: elevators, stairwells, hallways, lounges, laundry rooms, offices, computer labs, conference rooms, dining facilities, community restrooms, and classrooms.

I agree to have a relocation plan in place to leave campus should Student Housing and Residence Life and/or Cameron University partially or fully close.

I understand that food service on campus may be modified to safely serve the campus community.

I agree to the following visitation policy details:

The visitation policy for residents is in effect as listed in the Student Housing and Residence Life handbook with the exception that guest type is limited to currently enrolled CU students unless the Office of Student Housing and Residence Life approves family members at least two business days in advance. Visitation may be adjusted during opening and closing each year/term to accommodate for family members that may be assisting a resident. Visitation details may be adjusted and modified from the above for official university breaks, holidays, and intersession. I understand that as the COVID-19 situation evolves the Office of Student Housing and Residence Life may modify the visitation policy.

Documented violations of this visitation policy will result in each student entering the Student Housing and Residence Life conduct process and if found responsible after an administrative review each student will receive disciplinary action.

I understand visitation policies for spring 2022 may be modified at a later date.

I agree to immediately report to Student Housing and Residence Life staff if: I experience COVID-19 symptoms, I have tested positive for COVID-19, I have been in contact with someone who has/had COVID-19 symptoms and/or tested positive for COVID-19. Additionally, I agree to contact the Cameron University Coronavirus Hotline to provide details about my experience with COVID-19.

I agree to move to isolation/quarantine on campus housing if directed by Student Housing and Residence Life staff including following all requirements on meals, parking, visitor access, and apartment and building entry/exit.

I understand that I chose to live in Student Housing and Residence Life in a community and that includes a level of risk. I accept responsibility for this decision. I understand Cameron University and the Office of Student Housing and Residence Life is not liable for my personal health. I understand that should COVID-19 pandemic conditions change a complete closing of all Student Housing and Residence Life facilities is possible. I understand that failure to comply with policies may result in my contract being terminated, and in that case, the termination would be considered a cancellation on my part, and all normal terms and conditions would apply. I understand that my failure to adhere to this agreement may be deemed a risk to the campus community, and I will have voluntarily terminated the remainder of my Student Housing and Residence Life contract and might be required to vacate Student Housing and Residence Life facilities within 24 hours.
